## Description of Terms

**Term of agreement and Termination:** This agreement shall remain in effect for a period of one (1) year and may be terminated by either party at any time, with or without cause, by delivery of no less than 30 days advance written notice of termination.

**Services Provided:** All requests for services shall be initiated and approved by the McCall-Donnelly School District's Director of Special Programs prior to the Provider working with individuals.

**Billing and Payment:** Billing for services shall be delivered by the Provider to the McCall-Donnelly School District Administrative Office no later than the 10<sup>th</sup> of each month.

**Records and Reports:** The Provider shall maintain all treatment records and provide information when requested.

**Insurance:** The Provider shall maintain a comprehensive general liability insurance in the amount of \$1,000,000 each occurrence, and aggregate of \$3,000,000, and provide the McCall-Donnelly JT School District No. 421 with a copy of the insurance certificate.

**Qualifications:** The Provider holds and maintains the required qualifications and licenses to perform their normal professional duties. Such information shall be documented and kept on file with the Director of Special Programs.

**Attorney Fees:** In any suit, proceeding or action to enforce any part or provision of this agreement the prevailing party shall be entitled to recover from the other party reasonable sums and attorney fees and costs and expenses as connected with the suit proceeding or action.

**Choice of Law:** The laws of the State of Idaho shall govern this Agreement.

**Compensation:** The Provider shall be paid at **\$60.00** per hour. Hourly rate shall include all evaluations, consultation, and treatment. Travel time other than to primary work site shall be compensated at the state travel reimbursement rate (currently at .58 cents per mile).
