McCall-Donnelly School District is soliciting non-sealed electronic competitive proposals for Category 1 – Wide Area Network services for funding year 2019. All work pursuant to this contract shall be contingent upon E-Rate funding approval by the SLD. Any bid received later than the deadline time shall be automatically disqualified.

General Conditions

- The District reserves the right to reject any or all proposals submitted.
- Service provider will provide a brief summary of the company's background, including an outline of qualifications.
- Service provider must be registered as a service provider with the Schools and Libraries Division (SLD), have a Service Provider Identification Number (SPIN), and comply with all SLD service provider requirements. SPIN number must be provided in proposal
- Service provider must use Service Provider Invoice (SPI).
- Contract must not contain an auto-renew clause.
- License to practice in Idaho

Instructions

- All proposals must be submitted electronically to mcavallin@mdsd.org no later than the date and time specified. An e-mail confirmation will be provided to all final proposals.

Evaluation

- Each proposal will be evaluated according to the following factors and weights.

Factor	Points Available
Price of the eligible products and services	50
Prior experience with the vendor	25
Prices for ineligible services, products, and fees	15
Local or in-state vendor	10
Total	100

Contracts

- Contracts must be signed by Superintendent with authorization of the Board of Trustees
- Award of this proposal is contingent upon the approval of funding from the Schools and Libraries Universal Service Administration Company (USAC).
- Contract will take effect on July 1, 2019 through June 30, 2022.
- All contracts must have a clear clause that states “Contingent upon E-Rate Approval”.

Services Required

The McCall-Donnelly School District is seeking Data Transmission Service - Wide Area Network. Service can be leased-lit fiber or dark fiber.

- 1gb/s or 10gb/s connecting McCall-Donnelly High School to Barbara R. Morgan Elementary School
- 1gb/s connecting McCall-Donnelly High School to Donnelly Elementary School
- Allows the District to pass their own VLAN's across the service
- Proposal should have cost option of 1gb/s and 10gb/s
